Authorisation Examination for the Application of Authorisation of a Service Provider for Electrical Installations as per Electrical Installations Regulations (S.L.545.24) – July 2025

1. Id-Direttur tal-Eżamijiet u l-Bord tal-Eżamijiet Pubbliċi Lokali jgħarrfu li se jsiru eżamijiet tat-teorija tal-Elettriku u tat-Teknoloġija tal-Installazzjoni Elettrika bejn it-Tlieta, 1-1 ta' Lulju, 2025 u l-Ġimgħa, 4 ta' Lulju, 2025, sabiex l-applikanti li jgħaddu jkunu jistgħu japplikaw għand ir-Regolatur għas-Servizzi tal-Enerġija u l-Ilma (REWS) għall-ħruġ ta' Awtorizzazzjoni 'A' u 'B', kif stipulat fl-Att dwar ir-Regolatur għas-Servizzi tal-Enerġija u l-Ilma (Kap. 545) u r-Regolamenti dwar l-Installazzjonijiet Elettriċi (L.S.545.24).

1. The Director of Examinations and the Board of Local Public Examinations notify that the examinations for Electrical Theory and Electrical Installation Technology will be held between Tuesday, 1st July, 2025 and Friday, 4th July, 2025, to enable successful candidates to apply for the issue of Authorisations 'A' and 'B' at the Regulator for Energy and Water Services (REWS) as stipulated in the Regulator for Energy and Water Services Act (Cap. 545) and Electrical Installations Regulations (S.L.545.24).

Candidates need to pass from both written papers of the same examination session to be eligible for the practical/interview test.</p> <p>6. Candidates who passed in both written papers but did not pass in the Practical/Interview Test do not need to sit for the written papers again as long as the practical/interview test is taken within a period not exceeding 2 years from the written test.</p> <p>7. To be able to apply with REWS for Authorisation 'A' or for Authorisation 'B', candidates must obtain a pass mark in both Paper I and Paper II together with a pass mark in the Practical/Interview Test.</p> <p>8. Applications will be available online between Monday, 12th May, 2025 and Friday, 23rd May, 2025 from (https://myexams.gov.mt/applications/).</p> <p>9. Late applications will not be considered.</p> <p>10. The Board of Local Public Examinations has the power to deal summarily with any candidate who while the examination is in progress, is found to be guilty of any breach or misconduct, of the Instructions to Candidates included with the timetable.</p> <p>11. The Board of Local Public Examinations reserves the right to annul the examination and/or disqualify the candidate/s if any irregularity is detected at any stage of the examination. Such annulment and/or disqualification may be in respect of the whole examination even if the detected irregularity is in respect of only one paper.</p>
